**Sub: Intimation pursuant to Regulation 30 of the SEBI (LODR) Regulations, 2015 regarding interim order passed by the Hon'ble High Court of New Delhi in the matter of Minosha India Limited ("MIL") (Formerly known as Ricoh India Limited) V/s. Fourth Dimension Solutions Limited ("FDSL")**

With reference to the above subject and in compliance with the Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform that the Hon'ble High Court of New Delhi in the matter of MIL V/s. FDSL on 22<sup>nd</sup> March 2023 (order received on 27<sup>th</sup> March 2023) passed an interim order stating that the arbitration proceedings in the matter of MIL v/s. FDSL for the Education and Research Network project ("ERNET") shall be subject of the outcome of the petition filed by MIL before the Hon'ble High Court of New Delhi.

The said petition was filed with the prayers to set aside the Arbitral award dated 20 January 2023 passed by the Hon'ble Arbitrator Mr. Justice (Retd.) Manmohan Sarin.

**Background of the matter**

The Arbitration proceedings between FDSL v/s. MIL is ongoing before the Sole Arbitrator i.e Justice Mr. Man Mohan Sarin (Retd.) for the claim amount of Rs. 18,07,80,897 together with interest @ 18% P.A from 19.01.2017 claimed by FDSL from MIL for ERNET project which was jointly executed.

MIL raised preliminary objections, to the maintainability of the Arbitration proceedings and further seeking termination of such Arbitration proceedings, before the Mr. Justice (Retd) Manmohan Sarin. The Hon'ble Mr. Justice (Retd) Manmohan

Against the order of the Hon'ble Justice Mr. Man Mohan Sarin (Retd.) dated 20<sup>th</sup> January 2023, MIL filed an application before the Hon'ble High Court of New Delhi to set aside the Arbitral award dated 20<sup>th</sup> January 2023 passed by the Hon'ble Sole Arbitrator Mr. Justice (Retd) Manmohan Sarin, the status of which is currently pending adjudication.
