होंगे और मतगणना आठ सितंबर को होगी।

उत्तर प्रदेश में घोसी सीट पर सपा विधायक दारा सिंह चौहान के इस्तीफा देकर भाजपा में शामिल होने के कारण उपचुनाव कराया जा रहा है। उत्तराखंड की बागेश्वर सीट विधायक चंदन राम दास के निधन के बाद खाली हुई है।
